#### **MINUTES: 09 OCTOBER 2007**

OPENING CEREMONY: 1911 HOURS, PLEDGE OF ALLEGIANCE, OPENING PRAYER.

MINUTES OF PREVIOUS MEETING: APPROVED AS WRITTEN.

CORRESPONDENCE: SR. VICE GOODROW READ A LETTER THAT THE DETACHMENT RECEIVED FROM THE FRANKLIN GRANVILLE VANCE PARTNERSHIP FOR CHILDREN (HEAD START), THANKING US FOR OUR RECENT CONTRIBUTION TO DOLLY PARTON'S IMAGINATION LIBRARY IN FRANKLIN COUNTY. OUR DETACHMENT'S CONTRIBUTION MADE IT POSSIBLE FOR 10 CHILDREN TO RECEIVE QUALITY BOOKS IN THEIR HOME MONTHLY THROUGH JULY 2008. ## **REPORT OF OFFICERS:**

- **COMMANDANT DANGLER:** REPORTED ON THE DEPARTMENT ON NC'S QUARTERLY MEETING IN WHICH OUR DETACHMENT HAD 5 MEMBERS IN ATTENDANCE.
- SR. VICE GOODROW: REPORTED A CHANGE TO THE NATIONAL BYLAWS, WHICH ALLOW FOR THE WEARING OF ONE, TWO OR A MAXIMUM OF THREE LARGE (STANDARD) MCL OR DOD MEDALS WITH THE RED BLAZER.
- JR. VICE O'NEILL: REMINDED US THAT WE ALL NEED TO BE RECRUITING NEW MEMBERS AND WORKING TO RETAIN THE ONES WE ALREADY HAVE. WE SHOULD CALL UPON THE ONES WHO ARE DUE TO RENEW THEIR MEMBERSHIPS THIS MONTH. ALSO, WE NEED TO MOTIVATE THE MEMBERS WHO HAVE NOT BEEN TO A MEETING IN A WHILE.

#### **UNFINISHED BUSINESS:**

• MARINE CORPS BALL: THE SR. VICE DOESN'T HAVE MUCH ADDITIONAL INFORMATION YET CONCERNING THE BALL OTHER THAN WHAT WE ALREADY HAVE, BUT HE WILL PUT THE

INFORMATION OUT AS HE GETS IT. THE ADJUTANT WILL SEND OUT AN E-MAIL REQUESTING THAT ALL WHO PLAN TO ATTEND THE BALL TO LET JOE KNOW, SO HE CAN GET A HEAD-COUNT. MEMBERS WHO PLAN TO ATTEND WOULD PREPAY SO THAT THE DETACHMENT ONLY HAS TO SEND ONE CHECK TO COVER EVERYONE.
