9. REPORT OF OFFICERS

- A. Senior Vice Commandant Brandon reported on the gun raffle ticket sales and approximately 3000 tickets remain for the Capital City Gun Show this week and the Dixie Gun Show on 4/5Aug2012. He noted we need volunteers for these shows as well as a Gun Show in Greensboro on 25/26Aug2012.
- **B.** Brandon has acquired an LM 308 AR-style rifle for the 2012/13 raffle season. This weapon will be presented at the August Dixie Gun Show at a separate table next to the 6.5 Grindel table. And we will start selling tickets for it as well as selling the remaining tickets for the 6.5 Grindel.
