Minutes of the Air, Land, NC Detachment 1257 Monthly Meeting: 12 Feb2013

Presentations

1. Franklin County Deputy Sheriff Wayne Daniels

Deputy Daniels presented the Franklin County Miracle League which provides an opportunity for disabled children to play baseball and other sports. Throughout 42 states, there are over 200,000 children involved in the Miracle League. In 3 counties, including Franklin, Vance and Granville, there are 978 families with disabled children who can become involved with Miracle League. They currently have four teams of children involved and are looking to include more. In addition, there is a number of middle school and high school students who help the disabled children participate. The League is looking for donations of \$250 to sponsor one team. We told Deputy Daniels that we would consider a donation of \$500.

2. **Jeanette Whalen**

Jeanette provided a presentation on Advanced Directives, which are the documents you may want to prepare for your relatives and medical personnel to follow for your end of life wishes. These documents include a Living Will, a Health Care Power of Attorney and a Do Not Resuscitate Order. She provided examples of these documents and discussed their use.

B. Senior Vice Commandant - SVC Holliday is asking for additional volunteers for the Capital City Gun Show on 23-24Feb2013. Please sign up after the meeting. He again noted that a new coordinator for the gun raffles will be needed for the coming year. The new coordinator can either be a full member or an associate member, qualified to purchase the guns. He will train the new coordinator. The new coordinator will be provided a per diem of \$100 for each gun show. No one has come forward to date. SVC Holliday elaborated on the fund raiser produced by Brax Fundraising out of Wilmington, NC. They produce a series of items - Spirit Cups, Spirit Popcorn and Spirit Travel Cups - which can be imprinted with various sports organizations, colleges and military organizations. These items can be sold to friends, neighbors and at gun shows to raise additional funds for charitable giving. Four cups can be sold for \$18, of which we make \$6.
